Students in grades K-11 who scored 90% or higher in reading and/or math on the MAP assessment are eligible for further evaluation for the Gifted program. It is administered by a teacher who knows the child well. The teacher rates specific gifted behaviors that they have observed over time. Students that meet 90% or higher in both creativity and motivation will be administered the CogAT.	Each district grading cycle

Georgia Milestones is a single assessment system that consists of end-of-grade measures in English and math in grades 3-8, end-of-grade measures in science in grades 5 and 8, and end-of-grade measures in social studies in grade 8.
